## Dragon Boating Waiver of Liability Release, Indemnification and Hold Harmless Notice

I, the undersigned, in consideration for receiving permission to participate in dragon boating and to enter the premises, waterways and grounds supervised or in any way controlled by the organization and the receipt of said permission being hereby acknowledged, do hereby forever RELEASE any and all liability, discharge and agree not to sue the Ithaca Asian American Association (IAAA) and it's Dragon Boat program their agents, members, partners, trustees, representatives, officers, sponsors, licensors, servants, volunteers and employees. I agree to hold and save them HARMLESS and indemnify them from and against any and all liabilities, claims, injuries, losses, damages, expenses, demands, actions and course of action whatsoever kind of nature arising out of or related to any such loss, damage, or injuries including death that may be sustained by me for whatever reason while participating in or upon the grounds supervised or controlled by the Ithaca Asian American Association (IAAA) or en route to or from these premises leased, permitted, supervised or controlled by IAAA, whether such damages are the result of negligence or for any other reason or cause. I also agree to reimburse the IAAA and its respective agents, members, partners, trustees, representatives, officers, sponsors; licensors and servants with the associated costs incurred by them. I also agree to and discharge forthwith on request of the IAAA and its respective agents, members, trustees, representatives, officers, sponsors, licensors, servants, volunteers and employees and their authorized representatives, each and every obligation or claim which will be made, assigned or apportioned against the IAAA, it's dragon boat program and its respective agents, member, trustees, representatives, officers, sponsors, licensors, servants volunteers, and employees by any party by virtue of any injury or damage caused to me.

I am duly aware of the risks and hazards inherent in the sport of dragon boat racing and upon entering the premises used for the purpose of officiating, launching, docking and storing equipment used the sport of dragon boat racing and participating in the dragon boat program and clinic held on the Cayuga Lake Inlet and Cayuga Lake. Participating in said event, even if on a volunteer basis, knowing conditions may be hazardous and dangerous, that obstructions may exist, and that high winds may exist and cause rough waters, I hereby voluntarily assume all risks of loss, damage or injury including death that be sustained by me or to any property while in or upon said premises or engaged in said event. This Waiver includes injuries, damages or loss occurring on water, in water or in the air.

In signing the Waiver, I acknowledge and represent that I have read and understand this release and agree to it voluntarily. I further understand that I am specifically waiving certain rights by this release to which I may have otherwise been entitled. I attest that I am 18 years of age and of sound mind.
